**LOAN PROCESS

If you or your parents need and decide to take Federal Loans with or without subsidy of interest of the Direct Loan Program to help cover education expenses; you will be required to complete the following:

STEP 4: Complete the Entrance Counseling

- a. Access <u>https://studentaid.gov/entrance-counseling/</u>
- b. Have on hand:
 - a. Your FSA ID (See step 1).
 - b. School name.
 - c. Details on your income, financial aid and living expenses.

STEP 5: Complete the Master Promissory Note (MPN)

- a. Access https://studentaid.gov/mpn/
- b. Have on hand:
 - a. Your FSA ID (See step 1).
 - b. Personal information.
 - c. School name.
 - d. Reference information for two people with different PR or US addresses who have known you for at least 3 years.

STEP 6: The Financial Aid Office will contact you if additional information is needed.

STEP 7: An estimated Financial Aid Offer will be provided.

- a. Carefully read the offer.
- b. All gift aid will be assumed accepted. If you wish to reject gift aid contact the Financial Aid Office.
- c. If you are in agreement with the loan amount offered, you must accept. Remember loans must be repaid with interest. If desired, you can reduce the amount of loans. (Instructions are provided).
